Dear Valued Investor,

Contained in this letter are web link addresses to important updated documents relating to: **European Finance Opportunities S.C.A. SICAV-SIF Prime Alternative Finance Fund (PRALTF)**, its Investment Manager and other key Service Providers. We recommend that you review these documents and retain them for future reference. To ensure that you access the latest version of these documents, please refresh your web browser.

Following the approval of the Commission de Surveillance du Secteur Financier (CSSF) dated February 2022, we hereby inform you that the Managing General Partner of the Fund has amended the Private Placement Memorandum of the Fund (the PPM) to reflect the following changes:

- a) Creation of a full set of new M Share Classes within PRALTF to be available for all new subscribers from 31 March 2022 onwards. Like the existing share classes, the new share classes will operate either as distribution or capitalisation share classes. The addition of those new classes led to a reshuffling of the share classes description in the PPM.
- b) Although the subscription terms of the existing share classes remain unaffected by the proposed changes and additions, these share classes are now closed for subscriptions except at the discretion of the Managing General Partner.
- c) Deletion of any reference to listing with the Main Market Securities of Euronext Dublin share classes of the Fund are no longer listed on this market.
- d) other legal / regulatory and non-material updates.

As a final update, we note that on 23rd April 2020 the Managing General Partner resolved to activate a gate mechanism, via a Circular Resolution dated the same date. The Gate was implemented over the next two dealing dates, e.g. 30 April 2020, and 31 May 2020 only. The Managing General Partner has now formally and retroactively de-activated the Gate and reverted back to the default redemption terms as described in the Fund's PPM.
