

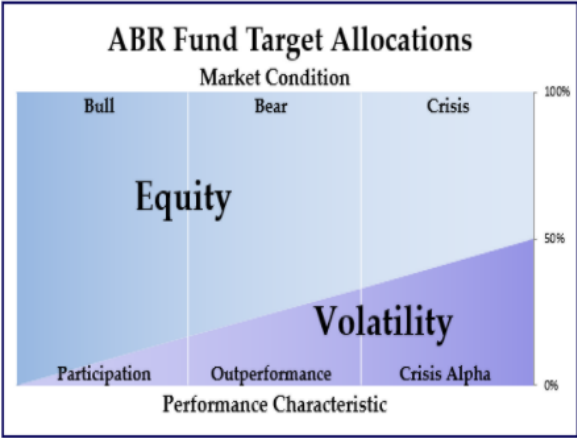
ABR Dynamic Blend Equity & Volatility Fund

(Inv - Inst Classes)

FUND DESCRIPTION AND OBJECTIVES

The ABR Dynamic Blend Equity and Volatility Fund is a sub-fund of MontLake Corrib UCITS Platform ICAV, an Irish collective asset management vehicle constituted as an umbrella fund with segregated liability between sub-funds with registration number C155133. The investment objective of the Fund is to achieve investment returns by investing at least 80% of the NAV in futures listed or traded on one or more recognized markets that provide exposure to US large-cap equity securities including volatility in the US equity markets. The Fund's performance target characteristics are to generate long-term outperformance with reduced swings and drawdowns, by producing:

- Partial equity participation in a bull market
- Outperformance of equities in a bear market
- Significant positive returns in a crisis



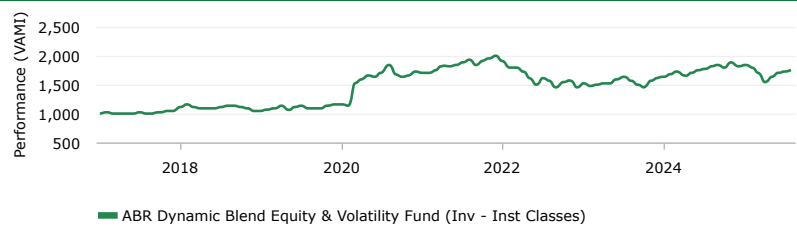

IM COMMENTARY

In August, the S&P 500 continued its recovery, gaining 2.03% in its fourth straight month of gains. The decline in volatility continued at a significant pace, with volatility dropping 14.37% during the month (as measured by short-term VIX futures – SPVIXSTR Index). The ABR Dynamic Blend Equity and Volatility Fund’s model is primarily a volatility trend-following model. Because the moves in August were generally continuations of the trends from previous weeks and months, the model was well-positioned to partially participate in the equity rally, albeit with some negative contribution from the outsized decline in volatility. For the month, the Fund gained 1.03%.
